## "Cush" Lewis Tells About Jesse James

Declares He Saw the Man ''Howard'' Before and After Death, and Knows That it Was Howard That Was Shot

VISITED LEWIS AT HIS HOME

Was in Connection With the Hanging of the Talbott Boys That Cush Saw James

The man claiming to be Jesse James that is getting much publicity in St. Joseph is undoubtedly not the real Jesse James, according to Cush Lewis, who told a member of the Bulletin force Wednesday about meeting James and afterwards viewing his dead body. The meeting of the famous outlaw came about through Cush's interest in the Talbott Boys who were hanged for the killing of their father in 1882. Lewis says he lived neighbors with the Talbott family and knows much of the circumstances and facts surrounding the death and subsequent trial and hanging of the Talbott Boys.

It seems that after the trial, the Talbotts were taken to St. Joseph for safekeeping, according to Lewis, who declared the jail in Maryville was not strong enough to hold anyone. Cush made frequent trips to the jail in St. Joseph to visit his old neighbors.

#### Met "Poke" Wells

It was on one of these trips to the St. Joseph jail that Lewis met "Poke" Wells, who was in jail for some kind of a crime. "Poke," according to Lewis, was a bad man, ruthless, a killer, and very anxious to get out. "Poke" told Cush that Jesse James was living in St. Joseph under the name of Howard, and that if he could be bailed out of jail, he could get James to take the Talbott boys from the jail and save their lives from the noose.

"I told Wells that I would see Mrs. Talbott about the bail," said Cush, "and if she said so, I would get him out and we would see what could be done. Mrs. Talbott gave her consent to the attempt to get the boys out by force, and authorized me to sell any number of mules necessary to get the

Talbott's rooms which were in the upstairs of the building east of the First National Bank building in Maryville." Lewis didn't say what the conversation was about but he did say that he didn't believe the man claiming to be Jesse James today is the man.

The hanging occurred on July 22, 1881. This is the last time Lewis saw Howard alive, In fact he only saw him two times; once at his home and once in Maryville on the day of the execu-

#### Viewed Body

But Cush saw the body of the dead Howard and declares that the man he talked with on two occasions was the same man that lav a corpse in St. Joseph, "I don't know whether the man I talked to was Jesse James or not, I only know that he told me he was Jesse James, but I do know that the man I talked to on the two oceasions was the dead man," said Cush. "I believe that Uncle Dave McKee is right when he says the man claiming to be Jesse James is his cousin, I know that the man Howard who called on me and the man Howard who was shot in St. Joseph by Bob Ford was the same person, for I was just that curious that I made a trip to St. Joseph to see the body."

"Since this man has sprung up to claim he is the real Jesse James, I have had a number of letters from old friends asking me to come to St. Joseph to see him and try to identify him. I may do it yet if I get to feeling well enough."

Cush Lewis, who will be 76 years old on July 25th, is one of the early settlers here and is widely known over the county. He has been in ill health for a number of years.
